Program Summary:

Southern Screams invites schools and non-profit organizations to participate in our Partner Referral Program. Approved partners will receive a unique referral/promo code to share with their network. For each qualifying ticket sold using that code, the organization will receive a percentage of the sales (minus any discounts applied during the transaction) as a commission or donation.

Program Benefits

You'll receive a unique promo or referral code to share with your community. For every qualifying ticket sold using your code, your organization earns a commission based on total volume:

0–24 tickets	25–75 tickets	76–150 tickets	151–250 tickets	251+ tickets
Not eligible	20%	25%	35%	40%

A minimum of \$100 in earnings is required to trigger a payout. Share your code however works best — email, social media, newsletters, QR codes, you name it.

Eligibility

This program is open to registered schools and 501(c)(3) nonprofits. Individuals are not eligible. All applicants must agree to these terms and complete a short onboarding form. Southern Screams reserves the right to approve or deny any application.

Payment Terms

Payments are issued by check within 30 days after the event concludes. If your organization earns more than \$600 in a calendar year, we'll request a completed W-9 and issue a 1099-NEC.

FTC guidelines also require that you disclose to your audience that you may receive a commission for referrals. Misrepresentation of the offer or our brand may result in removal from the program.

Tracking & Reporting

We'll report sales attributed to your code upon written request, no more than once per week. Final season reports are available within 7 business days after we close for the year.

Commission or Donation — Your Choice

Partners may treat their earnings as a marketing commission or as a charitable donation from Southern Screams. Whatever works best for your organization.
